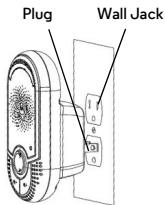

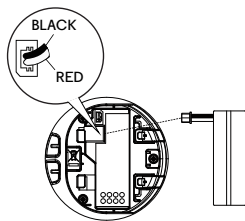
## 1. Setting up your Digital Audio Baby Monitor

### A. Connecting baby unit to power.



- Choose a proper location with easy access to an electrical outlet.
- Plug the baby unit into the electrical outlet in your baby's room. Ensure sufficient clearance is given for it to detect sound and place it not more than 5 feet away from the baby's crib.

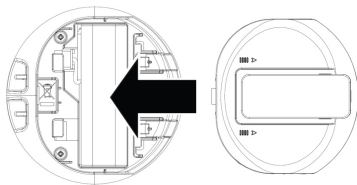
### B. Installing battery and connecting parent unit to power.



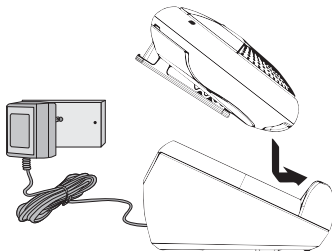
- Slide off the battery compartment cover.
- Insert the plug of the battery pack into the jack inside the battery compartment, and fit the battery pack into the compartment.

C. Slide the battery compartment cover back until it securely clicks into place.











D. Place the parent unit onto the charger. Connect the power adaptor of the charger to the electrical outlet.



**NOTE**

*Only use the provided battery pack and Power Adaptor (6V DC/400mA).*

## 2. Basic operation of the keys

	<b>POWER ON/OFF button</b>	Press and hold to power on/off the baby unit.
	<b>NIGHT LIGHT button</b>	Press to turn on/off the nightlight.
	<b>Volume UP button</b>	Press to increase the speaker volume.
	<b>Volume DOWN button</b>	Press to decrease the speaker volume.
Parent Unit		
	<b>POWER ON/OFF button</b>	Press and hold to power on/off the parent unit.
	<b>Volume UP button</b>	Press to increase the speaker volume.
	<b>Volume DOWN button</b>	Press to decrease the speaker volume.
	<b>TALK button</b>	Press and hold to talk to your baby.
